

SHIRO TWIST CHALLENGE TERMS AND CONDITIONS

1. Eligibility

The Shiro Twist Challenge is open to all individuals, regardless of residency. However, please note that employees of IPPUDO Malaysia are not eligible to participate in the Shiro Twist Challenge.

2. Challenge Mechanics

- ii. Record yourself doing the Shiro Twist Challenge in **under 1 minute**, showcasing your creativity in any way you like, such as singing, rapping, or dancing etc.

3. Intellectual Property Rights
